1 Background

Theatre and Dance NI (TDNI) is the sole support and representative professional membership organisation for theatre and dance in Northern Ireland with key goals to connect, support development and advocate for our artists and the industry.

Since 2017, TDNI have gathered evidence linking the sustainability of NI's cultural sector to the introduction of direct support for freelance artists. This programme has been shaped throughout by this extensive consultation as well as evaluation with artists, freelancers', sectoral stakeholders, and former participants.

2 Frequently Asked Questions

When is the deadline?

Friday 20th September at noon.

Where do I submit my application to?

Who can apply?

- We welcome individual applications from emerging artists, intending to develop their practice. If you are applying for the fellowship programme, you must have at least 2+ years' experience in theatre, dance and/or circus.
- You must have an active membership with Theatre and Dance NI. If you are not a member you can sign up by [clicking here](#). **Please be aware that if you are not a member of Theatre and Dance NI before the closing deadline of this application, you will not be eligible for this bursary.**
- We welcome applications from artists who have never applied for investment before.
- We welcome submissions from all eligible applicants, irrespective of religious belief, political opinion, race, age, gender, disability, marital status, sexual orientation, or people with dependants or without.

Who cannot apply?

- Those living and working outside of Northern Ireland.
- Those in full time education (students) and / or training.
- Under 21s.
- Full time employees of funded organisations, production companies, venues or community groups.
- Theatre and Dance NI staff and board members.
- Belfast City Council or Arts Council of Northern Ireland staff or board members.

Please note, this is a fund for the individual artist therefore you cannot apply as part of or on behalf of a partnership or collaborative group.

What will I do on INVEST Fellowship Programme? (if you are applying for the main INVEST programme, please see INVEST Programme FAQs and Guidelines)

- **Bursary** - £2,000. The bursary is to be used for developing your practice. This could include but is not limited to training course fees, individual tuition, conferences, related travel and accommodation, networking, residencies, seeing other work and research and development.
- **Support** – Direct support from the TDNI team, sector colleagues across UK, Ireland and beyond including award-winning producer Steven Atkinson (Royal Court, Long Acre Arts, HighTide) who is both a mentor and consultant on programme delivery and design.
- **Mentoring Prep** – Direct support to develop your skills and knowledge around how to get the most out of an industry mentor.
- **Networking** - Group sessions to encourage interdisciplinary collaboration - where artists can expect to gain access to national and international industry leaders. Previous networking events have included The Performing Arts Forum Gathering (Where Connections Make Change, Sligo) which was an opportunity for our INVEST artists to come together with the rest of industry from across the island of Ireland, to connect and reflect on how we can collaboratively shape our future. [A full list of attendees can be found here.](#) Previous INVEST artists also attended networking events with **Charlie Bunker** (Co-director, imPOSSIBLE producing), David Bryrne, (Artistic Director & CEO, New Diorama) and **Judith Dimant** (Exec Producer at Complicité), **Ciaran Walsh** (Associate Director, *Culture Ireland*) and **Shelia Creevy** (Chief Executive, Dance Ireland).
- **Training** - Skills development training sessions and workshops including an induction and two professional development residencies.

As part of the programme, TDNI will schedule several professional development training sessions. Most sessions will be held in person in Belfast. Some sessions have been pre-designed, and others will be co-designed with participants. While participants are advised to attend all sessions where possible, it is required you attend a minimum of three.

What is the difference between the INVEST programme and INVEST Fellowship Programme?

The INVEST Programme is for established artists with a minimum of 5 years' professional experience in theatre, dance and/or circus.

The INVEST Fellowship Programme is for emerging artists with a minimum of 2 years' professional experience in theatre, dance and/or circus.

Both programmes include the following:

- Networking opportunities.
- Personal time on your professional development.
- Direct support from the TDNI team, sector colleagues across UK, Ireland and beyond including award-winning producer Steven Atkinson

The INVEST Programme ONLY:

- One-to-one individual mentoring with industry experts.
- Bursary (£4,000)
- Two bespoke residential and attendance at a minimum of six professional development sessions.

The INVEST Fellowship Programme ONLY:

- Direct support to develop your skills and knowledge around how to get the most out of an industry mentor.
- Bursary (£2,000).
- Two bespoke residential and attendance at a minimum of three professional development sessions.

How long is the programme?

The programme will run from October 2024 and conclude no later than July 2025.

Where will I need to be?

Most sessions will be held in person in Belfast. Mentor sessions will be held either in-person or online. Residential location is to be confirmed.

What can I spend my bursary on?

INVEST solely exists to support artists professional development. This could include but is not limited to:

- Training course fees.

- Individual tuition.
- Mentoring (in addition to any mentor selected by you and the TDNI team).
- Travel and accommodation at festivals, training etc.
- Attending networking events.
- Professional development training including but not limited to intensives, classes, workshops, conferences, and meetings.
- Research and development.
- Residences.
- Seeing other work.
- Audience development.
- Daily rates - you should include a fee to cover your time whilst preparing, researching, participating, and reflecting on your professional development activity/activities.

This bursary should be spent on the aspect of your practice you wish to develop. When paying yourself or other artists, you should use the industry standard day/week rates relevant to your discipline. Please see [Independent Theatre Council](#), [Equity](#), [UK Theatre](#) and [Writers' Guild](#) for guidance on the rates of pay.

Can I go outside of the island of Ireland as part of INVEST?

We encourage artists to go see work and train nationally and internationally so INVEST can be used towards travel costs for professional development including training, workshops or to see other work.

What can the bursaries NOT be used for?

- INVEST does not directly fund the creation, production or touring of work. INVEST can be put towards the research and development of your creative processes that will ultimately develop your professional practice.
- Requests for retrospective costs or programmes/courses/training that have already begun or completed.
- Commercial projects.
- Work that forms part of under-graduate or post-graduate study or that will be assessed as part of an academic course.
- Work that forms part of existing professional or academic employment.

When does the programme take place?

Successful participants will be notified in September 2024. The programme should conclude no later than July 2025. **All applicants MUST be available for the following compulsory elements of the programme:**

- Induction – 16th October 2024 at 2pm (Belfast).
- Residential One - 27th-28th October 2024 (Belfast).
- Professional Development Day – 20th November 2024 (Belfast).
- Residential Two - 20th-22nd May 2025 (UK or Ireland).

I work for an organisation, can I apply?

This programme is designed for independent creatives only. If you are part-time in a creative role within an organisation, you are still welcome to apply if you can show that the professional development activity benefits your independent practice rather than the organisation or your role within the organisation. In addition, participants will be expected to attend compulsory sessions, so we urge you to consider this upon submission. You cannot apply if you are employed full time within an organisation.

I have had a bursary from Theatre and Dance NI (or Theatre NI or Dance Resource Base) before – can I apply again?

Yes, however you must have completed your previous evaluation report.

If you have been a previous participant in the INVEST programme, you are not eligible to apply. If you applied to the programme in the past and were unsuccessful, you may reapply.

Do I have to apply using the application form?

You can apply using the application form or submit a pre-recorded video/audio file for questions where this is stated on the application form. Use **WeTransfer or Dropbox** to share your video/audio file. Please make sure the link/s are working before your submission. If you are applying via pre-recorded video/audio, submit your link under each relevant question on the digital application form.

What supporting evidence should I provide with my application?

- Supply no more than two examples of your artistic work.
- Supporting evidence that best exemplifies your work and is of good quality video/audio.
- Clearly label the work with a title (i.e. in the file name) to show what it is or where it was presented.
- If your practice is performance-based, share a clip of a relevant event/show, rather than still images.
- Choose a clip from a performance, rather than promotional film as we want to see examples of your work. This can include a show reel so long as it demonstrates you and your practice.
- Do not submit video/audio materials that are more than five minutes long or work that contains large amounts of text.

- Use **WeTransfer** or **Dropbox** to share files and make sure the link is working before submission.

How will I provide evidence of my development as part of the programme?

This is a publicly funded programme. Participants will be required to share their experiences, processes, and progressions with Theatre and Dance NI, their mentor and their fellow INVEST artists. Please indicate clearly in your application how you intend to report your progress.

What should I include in my budget?

Please include **all** projected costs in your budget to achieve what you would like to do through the INVEST programme. Any additional cost above the bursary amount will be at your own expense and should be clearly evidenced within your budget.

Is my information kept private?

Yes. All information provided to Theatre and Dance NI will be held in strict confidence and is held solely to evaluate your application. Information about Bursary recipients will be shared publicly with the approval of the Artist.

3 Criteria for decisions

What is the INVEST panel looking for?

The INVEST panel will select the applications that best deliver the stated mission of the programme:

- Support a diverse group of artists to develop their careers and practice.
- Support artists in the longer term to create and produce work to the highest professional standards.
- Support artists to develop and sustain their careers.

A good application will give a snapshot of your current creative practice and the professional development you wish to undertake through INVEST. We encourage you to be realistic about what can be achieved.

The panel will make their decision based on the information provided. The decision-making process will be evidence-based. It is important to include all details in the application and support material.

Please do not assume that the selection panel have any prior knowledge of you or your work. If the programme is oversubscribed, you may be required to attend an interview with the selection panel. This would be no longer than 30 minutes.

4 Decisions

The Expertise

Additional advice will be sought if a particular form of arts practice is believed to be outside the panel's expertise.

Successful applications

Successful applicants will receive a contract from TDNI, and payment of 70% once relevant signed paperwork has been received. The final 30% will be paid on the conclusion of the programme (July 2024). All payments will be processed within 30 days of receipt of an invoice.

Unsuccessful applications

We will let you know by email no later than September 2024.
